- 51% of all items sold must be grown/produced by yourself (no reselling)
- You may sell up to 15% of your sales in non-consumable items if it is a byproduct of your main product (e.g. Beeswax lip balm, if you sell honey)
- You must provide copied documentation of any certifications or permits required to sell BEFORE you are allowed to sell at the market

**If you are selling processed foods that you are NOT making at the market:**

- Cottage License or Commercial Kitchen Certification from Utah Department of Agriculture (attach copies) More info: 801-538-7159
- Food Handlers Permit, 1 per vendor at each market. (attach copies)
- Required to Collect Sales and Use Tax (we will provide a temporary tax number)

**If you are selling items processed AT the market:**

- Temporary Food Permit from the Utah County Health Dept. (attach copies)\*\*
- Food Handlers Permit, 1 per vendor at each market. (attach copies)
- Required to collect Sales and Use Tax (we will provide a temporary tax number)

**If you are offering samples:**

- Sampling permit from the Utah County Health Dept. (attach copies)
- Food Handlers Permit, 1 per vendor at each market. (attach copies)

**\*\* Fresh grown unaltered Produce is not subject to sales and use tax or registration with the Department of Agriculture.**
